
You should show every employment, office trade or profession. You are not required





You should also declare any property from which you receive rent or on which you have lent money by way of mortgage. There is no need to declare any land where you are a trustee, of a trust with beneficiaries other than yourself or where you are the executor or administrator of an estate and you have no beneficial interest in that estate.




